IF YOU WISH TO VOTE AGAINST ANY RESOLUTION, TICK THE BOX MARKED (d) "AGAINST" BESIDE THE APPROPRIATE RESOLUTION. Failure to complete any or all boxes will entitle your proxy to cast his votes on the relevant resolution at his discretion. Your proxy will also be entitled to vote at his discretion on any resolution properly put to the Meeting other than those referred to in the notice convening the Meeting.
- (e) Under the Company's Bye-Laws, a resolution put to the vote of the Meeting shall be decided on a show of hands unless a poll is properly demanded; and on a show of hands, every member present in person or (being a corporation) by its duly authorised representative shall have one vote. AS THE CHAIRMAN IS ONLY ABLE TO EXERCISE ONE VOTE ON A SHOW OF HANDS, HE WILL USE THE VOTE FOR THOSE MEMBERS WHO WISH TO VOTE FOR THE RESOLUTION IF IT IS PUT TO THE MEETING. IF YOU WISH TO VOTE AGAINST THE RESOLUTION IF IT IS PUT TO THE MEETING, YOU MUST APPOINT A PERSON OTHER THAN THE CHAIRMAN OF THE MEETING. - This form of proxy must be signed by you or your attorney duly authorised in writing or, in the case of a corporation must be either under its common seal or under the hand of an officer or attorney duly authorised.
- In the case of joint holders of a share, if more than one of such joint holders is present at the Meeting, the vote of the senior who tenders (g) a vote, whether in person or by proxy, will be accepted to the exclusion of the votes of the other joint holders, and for this purpose seniority shall be determined by the order in which the names stand in the Register in respect of the joint holding.
- (h) To be valid, the form of proxy, together with any power of attorney or other authority (if any) under which it is signed or notarially certified copy thereof, must be deposited at the Company's branch registrar in Hong Kong, Tengis Limited at Ground Floor, BEA Harbour View Centre, 56 Gloucester Road, Wan Chai, Hong Kong not less than 48 hours before the time for holding the Meeting or any adjournment thereof.
